

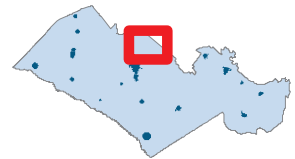
POLLING LOCATION MAP

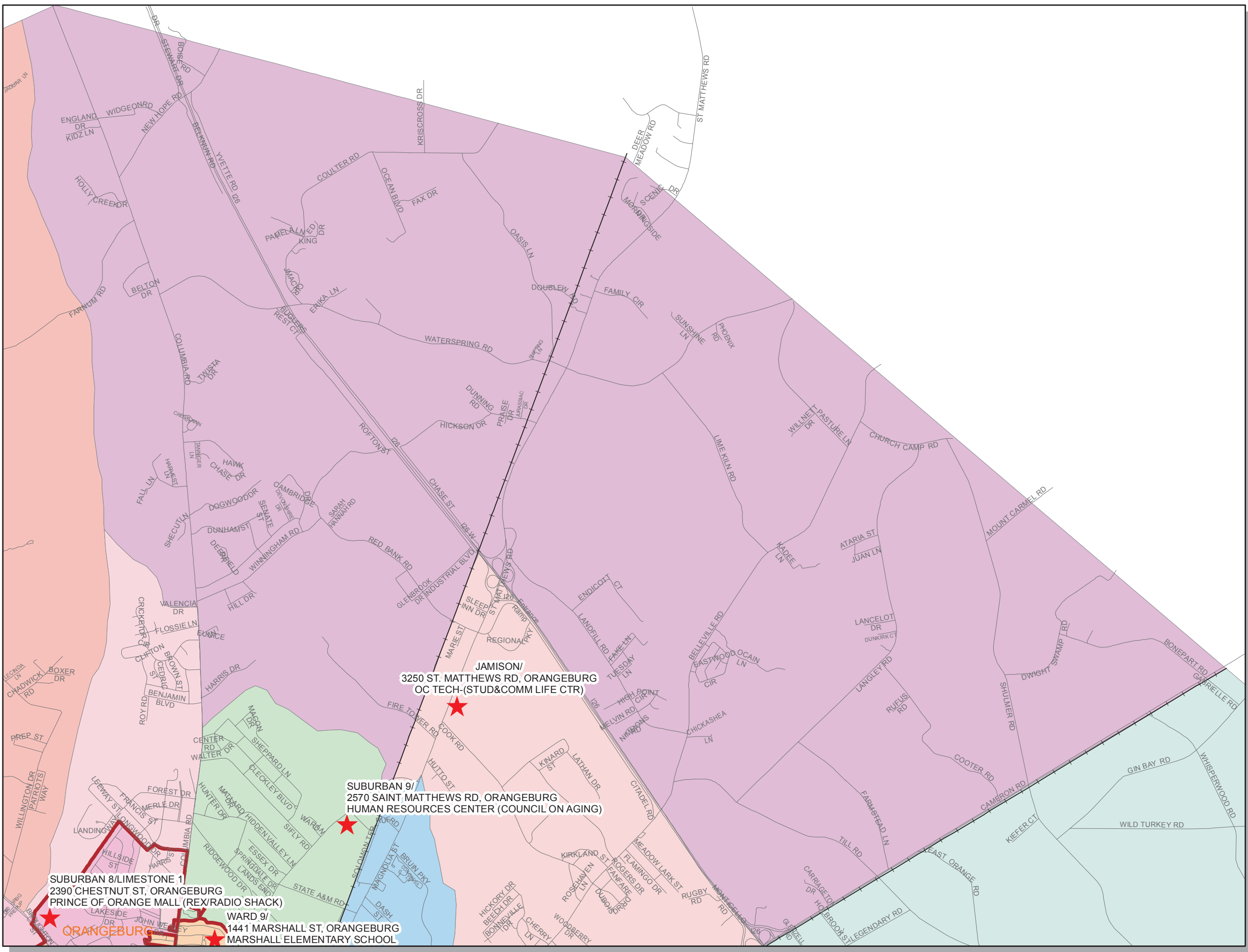
