- ❖ MANUFACTURES INSTALLATION MANUALS ON PUMP, FILTRATION SYSTEM, LIGHTS, HEAT SYSTEM, ETC.
- ❖ COPY OF THE RATIFIED CONTRACT BETWEEN OWNER AND POOL CONTRACTOR
